DEADLINE: All applications must be received by Friday, March 1, 2019.

Criterion for Schools Applying

- Must be publicly supported, accredited and in good standing for no less than three consecutive years;
- Must be located within and serve the student population of the Quad City area;
- Must offer band/instrumental music program serving 6th up through 12th grade students.
- Schools which received a Pops financial grant in fiscal year 2018 must report (in writing) how those funds were spent and how the instrumental program benefited before such schools receive consideration for 2019 grants.

Grants recipients will be notified in **April, 2019**.
